UNIT DIRECTOR OR CAPTAIN: Please **SHARE** this information with your unit members.

REGISTRATION: All unit members **MUST** be registered in order to perform or participate in walk-throughs.

LOCATION: Exhibit Hall C, Oregon Convention Center will be the venue for rehearsals and all evening programs.

QUESTIONNAIRE AND CD:

1. A separate questionnaire **MUST** be filled out for each performing unit and walk-through unit.
2. ***NOTE: CD MUST ACCOMPANY YOUR QUESTIONNAIRE – DEADLINE IS MARCH 31, 2012.**
Mail to Supreme Director of Uniformed Units.
3. Patrol and Chorus Units must also return one (1) completed copy of questionnaire to the appropriate Supreme Director for your unit.
4. The POSTMARK DATE on your envelope determines YOUR POSITION on the program for ALL EVENTS.
***EARLIEST DATE – EARLIEST PERFORMANCE**
5. Indicate your PREFERENCE for performing: Tuesday or Wednesday night. Every attempt will be made to schedule your unit for that night.

CD:

1. **MUST** be mailed WITH questionnaire NO LATER than March 31, 2012.
2. Label with your Temple Name, Number and Unit name, title of music, and running time.
3. ALL performances, including combined units, will be **FOUR (4)** minutes maximum or less.
PLEASE, NOTE PERFORMANCE TIME HAS BEEN SHORTENED
4. If music exceeds FOUR (4) minutes, it will be returned for editing.
5. Your CD may be picked up from the Supreme Director of Units after the evening's closing.

SPECIAL PERFORMANCES:

If your unit is performing at the Request of Supreme Queen Laura Richardson on SUNDAY or Supreme Princess Royal Suzie Schumacher on THURSDAY, send your questionnaire indicating the night you were invited to perform and your labeled CD, **NO LATER than March 31, 2012.**

WALK-THROUGH INFORMATION:

1. All units may participate in the walk-through on SUNDAY and THURSDAY nights.
Units without instruments:
 - (a) All will enter to Egyptian music that has been chosen.
 - (b) Entrances on the left and right side of the THRONE. Use a forward progressive step in a straight line around the arena. Exit opposite the side of the THRONE from your entrance.**Units with instruments:**
 - (a) Entrances on the left and right side of the THRONE. Use a forward progressive step in a straight line around arena – *playing as you go*. Exit opposite side of THRONE from entrance.
